I acknowledge that: I am aware of Southern Lodges terms and
conditions regarding deposits, cancellation procedures and possible price
changes.

I will sometimes travel on foot or be outside in the bush/on open water
where wild and potential dangerous animals can present a risk or a
potentially dangerous/live threatening situation can develop/take place.

Vehicle transportation will be supplied by Southern Lodges and I am
aware that sometimes participants will set out in open vehicles and I will
be subject to the natural elements and wildlife and acknowledge the
inherent risk of physical harm due to the unpredictable reaction of such
animals and take note that Southern Lodges disclaims all liability for any
client being the victim of such a risk or any other risks and dangers
involved apart from the above mentioned.

I will adhere to decisions taken by Southern Lodges employees /service
provider. If (in case of hunting) a decision is made that an animal has
been wounded but could not be found, I am still responsible for the
payment of such animal. If in the event an animal that is not shown on
Southern Lodges price list, is shot or wounded, I then agree that the full
(Euro/US dollar) price will be paid for such animal(s).

I commit myself to abide by the relevant Argentinean Laws regarding
any Acts relating to the activity/activities I will embark on.

Due to the nature of hunting there are no guarantees or warrants
concerning animals taken or specific animals being viewed as Southern
Lodges have no control over nature, weather, wildlife or my ability as a
